



Online Privacy Policy

This document sets forth the Webscape Online Privacy Policy (the "Privacy Policy") for this web site, www.webscape.co.bw (the "Site"). If you have objections to the Privacy Policy, you should not access or use this Site. This Privacy Policy does not govern privacy practices associated with offline activities or other Webscape web sites.

Changes in Privacy Policy

All "personal information" ("personal information" is defined as any information that identifies or can be used to identify, contact or locate the person to whom such information pertains) that we collect and maintain will be subject to the version of the Privacy Policy in effect at the time of such collection. Webscape reserves the right to change the Privacy Policy from time to time at its sole discretion, and will provide notice of material changes on the homepage of the Site.

Entities Collecting Personal Information

Personal information on this site is collected by Webscape, Webscape address is physical address (Plot 20701, Block 3, Broadhurst Industrial), postal address (P.O Box 2045, Gaborone, Botswana) and its telephone number is +267 - 390 - 5989.

The Site contains links to other sites at which personal information is collected. In such instances, unless expressly provided to the contrary, the collection and use of your personal information will be governed by the privacy policy applicable to that site. That privacy policy should identify the entity that is collecting your personal information.

Collection of Personal Information

As a visitor to this Site, you can engage in many activities without providing any personal information. Webscape may ask you to provide certain information about yourself by filling out and submitting an online form. It is completely optional for you to engage in these activities.

When you submit personal information to Webscape through this Site, you understand and agree that this information may be transferred across national boundaries and may be stored and processed in any of the countries in which Webscape and its affiliates and subsidiaries maintain offices, including without limitation, Botswana.

How your Personal Information is used

Webscape collects your information in order to record and support your participation in the activities you select. If you subscribe to a service or register a product, for example, the information is used to register your rights, if any, to technical support or other benefits that may be made available to registered users.

As another example, if you enter a contest, information is collected to qualify the entry and contact you regarding the contest or prize awards. Your personal information is also used to keep you informed about product upgrades, special offers, and other products and services of Webscape and selected third parties if you have so opted to receive such communications.
